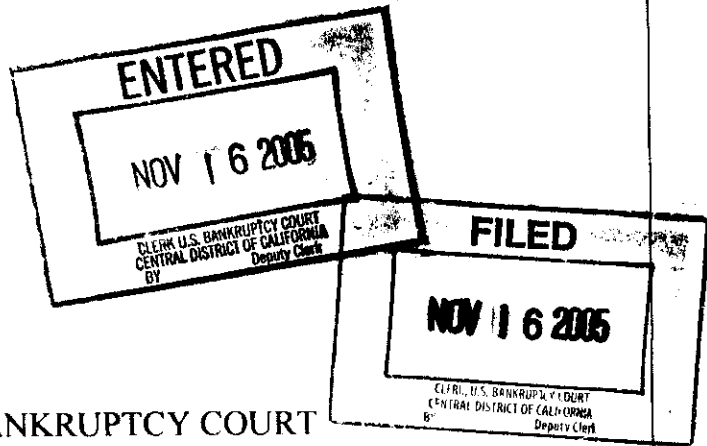

**AMENDED
TEMPORARY RESTRAINING
ORDER AND ORDER TO SHOW
CAUSE RE PRELIMINARY
INJUNCTION**

24 TO DEFENDANTS INTERNATIONAL VIDEO INNOVATION, L&M OPTICAL
25 DISC WEST LLC, DVD CONCEPTS, DIRECT VIDEO, DARA DISTRIBUTORS,
26 EAST BAY INC., MALLCOM INC., TRIPLE A VIDEO, ZEEV LAVY, DANNI
27 SKURA, ALON NOTEA:

1 YOU AND EACH OF YOU ARE HEREBY ORDERED TO SHOW CAUSE at the
2 time and place to be provided by plaintiff immediately or concurrently with the service of
3 this Order to Show Cause. The hearing shall be in the courtroom of the Honorable
4 Kathleen Thompson, on the third floor of the United States Bankruptcy Court located at
5 21041 Burbank Boulevard, Woodland Hills, California. At the hearing you are ordered to
6 show cause why you, your officers, servants, employees, and attorneys and those in active
7 concert or participation with you or them, should not be restrained and enjoined pending
8 trial of this action:

- 9 a) from replicating, marketing, distributing or selling DVD discs of any of
10 plaintiff's titles in your possession, custody or control, and
11 b) from refusing to turnover to plaintiff all replicas of plaintiff's Master's in
12 your possession, custody or control, and
13 c) from refusing to turnover to plaintiff all plaintiff's Master DVD discs,
14 Master DV-Cams, Master Beta-Cams, DLTs, stampers (glass masters), and
15 wraps in your possession, custody or control,
16 d) from refusing to immediately disclose to plaintiff the location of plaintiff's
17 masters, and/or DVD's, if those items are not in your possession or control,
18 e) and as to defendant International Video Innovation, in addition to the above,
19 from refusing to turnover 6,000 copies of DVD discs in your possession,
20 custody or control which plaintiff has paid for, a list of which is attached
21 hereto.

22 PENDING THE HEARING on the above Order to Show Cause, you, your officers,
23 servants, employees, and attorneys and those in active concert or participation with you or
24 them, are HEREBY ORDERED, RESTRAINED AND ENJOINED:

- 25 a) from replication, marketing, distributing or selling copies of plaintiff's
26 Masters in your possession, custody or control, and you are

- b) ordered to forthwith turnover to the United States Marshall upon his demand all replicas of plaintiff's Master DVDs in your possession, custody or control, and you are ,
- c) ordered to disclose to the United States Marshall the location of plaintiff's masters, DVD's and wraps, if those items are not in your possession or control,
- d) and as to defendant International Video Innovation, in addition to the above, you are ordered to turnover to the United States Marshall 6,000 copies of DVD discs in your possession, custody or control for which plaintiff has previously paid.

In addition to the above,

- 1. The U.S. Marshal shall assist in the seizure of the specified property.
- 2. The U.S. Marshal shall be allowed to use forced entry in the event of the U.S

Marshall's inability to gain access at the following locations:

- IVI, 20879 Plummer St., Chatsworth, CA 91311
- L&M, 24865 Ave. Rockefeller, Valencia, 91355
- DVD Concepts, 9801 Independence Ave., Chatsworth, CA 91311

- 3. The U.S. Marshal shall be held harmless for any wrongdoing arising from the seizure.
- 4. This Order shall be personally served on defendants IVI, L&M, and DVD Concepts at the time of the seizure.
- 5. The U.S. Marshal is directed to turn over the seized property to the Debtor (or its designee) to be the custodian of the property pending the hearing on the Order to Show Cause.

1 Upon the service of this Order on defendants, plaintiff shall give notice immediately
2 of a hearing to be held before this court no later than ten (10) days after this Order is
3 served. Any response or opposition to this Order to Show Cause must be filed and
4 personally served on plaintiff's counsel no later than 3 days before the date set for this
5 hearing, and proof of service must be filed no later than 5 court days before the hearing
